FEE POLICY

Pre-Admission Fee (Non Refundable)

An administration fee of **R250-00** is payable for registration for a prospective student. Any assessment bookings or interviews will only be confirmed once proof of payment and the required documents as listed on the Application Form has been received. The fee includes the cost of a compulsory Credit Risk Assessment.

Enrolment Fee (Non Refundable)

A non-refundable enrolment fee of **R2000-00** is payable once a student has been offered a place. Wait listing or enrolment will only be confirmed upon receipt of the enrolment fee and the successful completion of the information and documentation as required in the Application Form.

- Please note that the enrolment fee paid to Canterbury Kids will be offset against the enrolment fee required for Grade 0 entrance into Canterbury Preparatory School. Only the balance will be due.

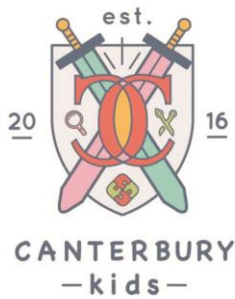
Option B: The annual fee can be paid over 11 monthly installments via direct transfer. Payment is due on the 1st of each month. Please use your child's name as reference.

Fee Policy

- Fees are subject to an annual increase.
- A 5% sibling discount will be applied to the younger sibling/s.
- All other invoices are payable on presentation.
- Students whose accounts are in arrears will be suspended until the account is brought up to date. Suspension is not indefinite and the pupil will need to be re-enrolled should payment not be made timeously.
- Overdue accounts will be charged interest at prime bank rate.
- All outstanding payments received will be applied firstly to the reduction of interest, tuition fees and fees in lieu of notice, and then to the reduction of current fees.
- Payments returned by the bank for any reason will incur a surcharge.
- Any bank fees relating to cash deposits or credit card payments will be charged to the parents account.
- A full terms notice in writing, or the equivalent fee in lieu thereof is required prior to the withdrawal of a student.
- The school shall be entitled to instruct its attorneys to attend to any overdue accounts and the parents shall be liable for any costs incurred.
- The school shall be entitled to list defaulting debtors on Transunion ITC.
